



School Annual Education Report (AER) Cover Letter

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2016-17 educational progress for Henry H. North Elementary School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2016-17 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was identified as an Additional Targeted Support (ATS) school.

As the M-STEP cut scores changed, our students had difficulty achieving academic success in all content areas. North Elementary School has a very unique population. We have the highest percentage of English Learners (ELs) in the Lansing School District, at 62%. Our students represent nearly 50 different countries, and speak nearly 30 different languages. Our school is very diverse. Along with our EL and general education population, we also have Hearing Impaired (HI), Visually Impaired (VI), and Physically and Otherwise Health Impaired (POHI) students. Each child at North is considered an individual learner, with our goal being to address the needs of each student so that they are successful in all aspects of their educational and social lives.

In 2017, in the area of English Language Arts, our 3rd grade students performed much better than our 4th, 5th, and 6th grade students on the M-STEP. In the fall of 2018 North Elementary will become a focus school specializing in Food, Energy, and the Environment (FEE). The school will have a new grade configuration and will service students in the 4th-8th grades. Using school district data, our focus is going to be on Reading Comprehension for all grade levels. North will continue to implement mandatory reading intervention blocks for all students. All teachers will be trained in the Daily 5 and CAFÉ reading programs. Also, in the area of Math, our 3rd grade students outperformed our 4th, 5th, and 6th grade students by nearly 10%. After reviewing district level data for 4th-8th grade students, we will implement mandatory math intervention blocks at every grade level, 4th-8th, for every student. We are seeing gains being made by our students due to these intensive interventions.

State law requires that we also report additional information.

1. Currently, North Elementary is a kindergarten through sixth grade school. Many of our students come from our attendance area, in South Lansing. We also receive English Learners living south of I-496, as we provide the needed ESL services for these students.
2. North Elementary continues to focus on three main goals in our School Improvement Plan. These goals include increasing student proficiency in the areas of English Language Arts, Math, and behavior. The school improvement process at North is ongoing and involves professional development for staff on best practices to provide the optimum educational experience for our students. The staff, students, parents, and community members all play an integral part in helping North Elementary to continue making progress in meeting all of its goals.
3. North Elementary School is a safe and caring learning community committed to developing students' social, emotional, intellectual, physical and ethical/moral well-being. Administrators, teachers, support staff, students,

parents, and community members strongly believe that caring relationships within our global community convey compassion and respect. High expectations for academic achievement and behavior, along with an understanding of our school's diversity provide a sense of belonging that make young lives meaningful and significant. Our differences are our strengths and we praise diversity for its potential to enrich teaching and learning experiences within the North School family.

4. A copy of the core curriculum, in addition to the Common Core State Standards (CCSS), can be accessed through the Lansing School District web page at www.lansingschools.net. The teaching staff at North Elementary uses the core curriculum and content standards, along with best practices for teaching and learning, to benefit each and every student.
5. Local tests such as the Developmental Reading Assessment 2 (DRA) AIMSweb, and DIBELS Next are administered at multiple grade levels, and at scheduled intervals, during the school year. The data provided by these assessments is taken into account while planning lessons and differentiating instruction for students, and also while preparing our school improvement plan.

The school will work with the State of Michigan to increase student proficiency in reading and math scores.
