A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%.   - Concepts & Application 29% increase in student proficiency from Fall 2019 to Winter 2020.
  - Mental Computation Fluency 7% increase in student proficiency from Fall 2019 to Winter 2020.

  - Early Literacy 4% increase in student proficiency from Fall 2019 to Winter 2020.
  - Letter Naming Fluency 11% increase in student proficiency from Fall 2019 to Winter 2020.

101 K-3 families out of 162 families (62%) attended Fall 2020 conferences.
