

## **Lansing School District Athletic Eligibility Policy**

## 2021-2022

Student-athlete must meet criteria 1-3 to be eligible to participate in Lansing School District Athletics.

- 1. Must pass at least 66% (4/6 or 6/8) of classes the previous semester (MHSAA minimum requirement).
- 2. Meet grade level credit requirements:

Freshman	1 <sup>st</sup> Semester 2 <sup>nd</sup> Semester	All Eligible Must have 2.5 credits
Sophomore	1 <sup>st</sup> Semester 2 <sup>nd</sup> Semester	Must have 4.5 credits Must have 7 credits
Juniors	1 <sup>st</sup> Semester 2 <sup>nd</sup> Semester	Must have 10 credits Must have 13 credits
Seniors	1 <sup>st</sup> Semester 2 <sup>nd</sup> Semester	Must have 16 credits Must have 19 credits

3. Cumulative GPA must be 2.0 or above for all grade levels.

If cumulative GPA is <u>below</u> 2.0 GPA, student is placed on "academic probation" and must meet criteria's 1-4 to be eligible to participate.

- 1. Must pass 66% (4/6 or 6/8) classes weekly.
- 2. Must maintain a 2.0 GPA weekly.
- 3. Must submit weekly progress report to athletic director.
- 4. Must attend mandatory tutoring sessions twice weekly.
- Competition is suspended until criteria's 1-4 have been met.
- Students may practice and attend events. (Student may <u>not</u> be dressed in team uniform or on bench/sidelines during games).
- Only 1 APEX course allowed on traditional class schedule.
- If student-athlete is ineligible for 5 weeks consecutively, they will be released from team for the remainder of season.

## Appeals:

- Level 1: All appeals shall be submitted in writing to the School Athletic Director for review.
   The appeal should contain all the facts pertinent to the case, including sufficient documentation to make it possible for the MHSAA's Executive Committee to reach a decision.
- Level 2: All appeals shall be submitted in writing to the **District Athletic Director** for review.
   The appeal should contain all the facts pertinent to the case, including sufficient documentation to make it possible for the MHSAA's Executive Committee to reach a decision.
- Level 3: All appeals shall be submitted in writing to the Executive Director for the Office of School Culture for review. The appeal should contain all the facts pertinent to the case, including sufficient documentation to make it possible for the MHSAA's Executive Committee to reach a decision.
- Level 4: All appeals shall be submitted in writing to the **Executive Team** review. The appeal should contain all the facts pertinent to the case, including sufficient documentation to make it possible for the MHSAA's Executive Committee to reach a decision.
