The following treatment has been recommended for your family to treat head lice:

Directions for the use of Nix Crème Rinse: The following should be done over the sink only—NOT in the tub or in the shower.

- 1. Shampoo the hair with your every day shampoo.
- 2. Rinse & towel the hair dry.
- 3. Apply enough NIX to saturate the hair & scalp.
- 4. Leave NIX on the hair for 10 minutes.
- 5. Rinse the hair thoroughly with water.
- 6. Towel dry hair.
- 7. Remove all nits.
- 8. Check hair daily for live lice or nits. If either live lice or nits are found in between the scheduled treatment plan, treat as needed, with baby oil or vegetable oil. Remove all nits found.

CAUTION:

DO NOT use NIX on children under 2 months of age.

DO NOT use NIX on premature babies.

DO NOT use NIX on persons allergic to the product.

DO NOT use NIX on open cuts or sores.

- Nursing mothers may use alternative feeding for 2 days following the use of NIX.
- Pregnant women should NOT use NIX more than 2x during pregnancy.
- Pregnant women should wear gloves when applying NIX for the treatment of head lice.
- If possible pregnant women should consult with their obstetrician before using NIX.



Directions for the Use of Vegetable Oil or Baby Oil for the Treatment of Head LICE

- 1. Saturate the hair with either vegetable oil or baby oil.
- 2. Cover the hair with a shower cap.
- 3. Leave the oil in the hair for 8 hours.
- 4. At the end of the 8 hours, wash the hair with dish soap & water.
- 5. REMOVE ALL NITS.
- 6. <u>Check hair daily</u> for live lice or nits. If either live lice or nits are found treat with baby oil or vegetable oil. Remove all nits found.

DO NOT USE FUEL OIL

DO NOT USE KEROSENE

DO NOT USE VASEOINE OR MINERAL OIL
